GENERAL Note -

As specified in Section 11 of the Declaration of Assets Act 2018 -

- (a) any person who fails to make a declaration or who willfully makes a false declaration shall commit an offence and shall, on conviction, be liable to a fine not exceeding one million rupees and to imprisonment for a term not exceeding 5 years;
- (b) any person who, in any other manner contravenes this Act or any regulations made under it, shall commit an offence and shall, on conviction, be liable to a fine not exceeding 10,000 rupees;
- (c) any spouse who, without any reasonable excuse, fails to collaborate in disclosing his or her assets and liabilities for the purpose of fulfilling a requirement under this Act, shall commit an offence and shall, on conviction, be liable to a fine not exceeding 10,000 rupees and to imprisonment for a term not exceeding 6 months.

Notes

- 1. Name and address should be filled in **BLOCK** characters.
- 2. The form should be filled with black/blue pen <u>OR</u> typewritten and the declarant should initial on each page of the document.
- 3. In part (a), particulars of assets held by declarant, spouse and minor children: the declarant SHOULD declare assets for himself/herself, his/ her spouse and minor children.
- 4. Money, in any currency, in bank accounts in local banks, foreign banks and non-bank deposit taking institution/s (savings/ current and fixed deposit accounts and others).
 - In the column "Name of Account Holder": the declarant needs to specify whether the account is held:
 - by himself/herself;
 - by his/ her spouse;
 - o jointly with another person; or
 - o by his / her minor children.
- 5. Trust property (in any currency, both local and abroad)
 - "settlor" means a person who provides trust property or makes a testamentary disposition on trust or to a trust
 - "beneficiary" means a person, whether natural or corporate, entitled to benefit under a trust, or in whose favour a power to distribute trust property may be exercised;
- 6. Where the space in the form is inadequate, a separate sheet of paper may be used and should be signed by the declarant.
