THE DECLARATION OF ASSETS ACT 2018

Regulations made by the Prime Minister under sections 5 and 13 of the Declaration of Assets Act 2018

- **1.** These regulations may be cited as the Declaration of Assets (Declaration Forms) Regulations 2019.
- 2. In these regulations
 - "Act" means the Declaration of Assets Act 2018.
- **3.** The declaration form referred to in section 5(1)(a) of the Act shall be in the form set out in the First Schedule.
- **4.** The declaration form referred to in section 5(1)(b) of the Act shall be in the form set out in the Second Schedule.
- 5. These regulations shall come into operation on 24 August 2019.

Made by the Prime Minister on 22 August 2019.

General note

As specified in section 11 of the Declaration of Assets Act 2018 –

- (a) any person who fails to make a declaration or who wilfully makes a false declaration shall commit an offence and shall, on conviction, be liable to a fine not exceeding one million rupees and to imprisonment for a term not exceeding 5 years;
- (b) any person who, in any other manner contravenes the Declaration of Assets Act 2018 or any regulations made under it shall commit an offence and shall, on conviction, be liable to a fine not exceeding 10,000 rupees;
- (c) any spouse who, without any reasonable excuse, fails to collaborate in disclosing his or her assets and liabilities for the purpose of fulfilling a requirement under the Declaration of Assets Act 2018 shall commit an offence and shall, on conviction, be liable to a fine not exceeding 10,000 rupees and to imprisonment for a term not exceeding 6 months.

- **2.** The form shall be filled with black/blue pen **OR** typewritten and the declarant shall initial on each page of the document.

"settlor" means a person who provides trust property or makes a testamentary disposition on trust or to a trust.

"beneficiary" means a person, whether natural or corporate, entitled to benefit under a trust, or in whose favour a power to distribute trust property may be exercised.

7. Boat

The type of "boat" shall be specified as whether pirogue, pleasure craft (include speed boat and yacht), jet ski or others (*please specify*).

- **8. Definition of liability**: present financial obligation of the individual arising from past commitment, such as loans, credit card, finance lease and others.
- 9. Any property sold, transferred or donated to children of age and grandchildren, in any form or manner whatsoever, including income or benefits from any account, partnership or

trust – the declarant has to specify all types of assets that have been sold, transferred or donated.

10. Where the space in the form is inadequate, a separate sheet of paper may be used and **shall be signed** by the declarant.
